### Notes About Fees

1. A single 'Session' consists of morning attendance from 9.00am to 12.15pm or afternoon attendance from 12.15pm to 3.15pm. A full day counts as two sessions.
2. No fees are payable for FEET funded children.
3. The fees shown in the 2 middle columns are those payable by parents/carers for provision not covered by the EYFE grant including, inter alia, additional time, food for snack, Montessori provision and extra-curricular activities. Up to 15 hours EYF entitlement is normally available for all children from the start of the term following their third birthday up to the end of the term following their fifth birthday. We offer up to three funded hours per session for children staying for the morning session and up to six funded hours per two sessions for children staying for a full day. For children who are entitled to 30 hours funded entitlement, we offer a maximum of 28 funded hours per week and the fees shown are payable for provision not covered by the grant funding.
4. The school claims grant funding for all eligible children on receipt of appropriate signed forms from parents/carers. Failure to submit the correct forms will result in fees from the left column becoming payable.
5. The lunch hour fee is not payable if the child stays for the afternoon session.
6. Children who have reached school age (four years old prior to the start of the academic year) are expected to attend on a full-time basis unless agreed otherwise.
7. Fees are payable termly in advance. There are three terms in each academic year.
8. A full term's notice must be given in writing if a child will be leaving the school or if parents wish to cancel a place prior to the child's planned start date, i.e., before the last day of the preceding term.
9. On 29 July 2024, the Chancellor announced that as of 1 January 2025, standard 20% VAT rate will be added to private school fees from 1 January 2025. Any fees paid from 29 July 2024 relating to the term starting in January 2025 and onwards will be subject to VAT. Early years fees will not be subject to the addition of VAT.
